

EARLIEST DOCUMENTED M'MILLANS - 12th to 15th centuries

- 1132 **Gilchrist mac Cormaic**: Witness to deed in Book of Deer (*Gillacrist...an Gillamaol mac Cormaic* of MS 1467)
- c.1150-60 **Malcoluim mac Molini**: Witness to deed in Book of Deer (*Gillacoluim mac Gillamaol* of MS 1467 genealogy)
- c.1228 **Sythach Macmallon (Shaw MacMillan)**: Subject of agreement between Bp. of Moray & John Comyn of Lochaber [Moray Reg., 84]
- 1263 **Gillemor MacMolan**: Member of Inquest Jury in Dumbarton (*Maolmuire of MS 1467 ?*) [CDS, I, 461]
- 1273 **Cane McGillolane**: Witness to Devorgilla Balliol's charter (*Cainn "MacMillan" of MS 1467*) [RRS, David II, 264-6, No. 235]
- 1296 **Macrath ap Molegan (ap Maolagain = mac Mhaolain)**: Gave homage for lands in Dumfriesshire [CDS, II, 198]
- c.1308/1313 **Gylebright McMalene (a.k.a. Gilluth McMolene)**: Lands in barony of Glenken forfeit [RMS I, App. 2, No. 316]
- 1362 **Gylcrist Macmal**: Proprietor of Balmule / Balmakmolle in Fife [Inchcolm Chrs., SHS, 3rd Ser. XXXII (1938), No.37]
- 1377 **Thomam McMolyn** Adherent of Archibald Douglas lord of Galloway [Rotuli Scotiae (London, 1819), Vol. II, No. 2]
- 1392 **Slurach and ... Clanqwhevil**: Outlawed for participation in the "Raid of Angus" [APS, I, 579]
- 1396 **Shaw & Clachynnhe Qwhewyl**: Combatants in Perth "Battle of the Clans" [Andrew of Wyntoun, "Orygynale Cronykil", c.1425]
- 1411 **Lochluinn MacGillehmaoil**: Killed at Battle of Harlaw fighting for the Lord of Isles ["Book of Clanranald"]
- c.1431 **Newyn McMullane**: Member of Guild of Ayr [Somered MacMillan, "The MacMillans...", 99]
- 1452 **Sir Duncan Macmolane ("Sir"=Rev.)**: Witness at collegiate church of Kilmun, Cowal [S. MacMillan, "The MacMillans...", 39]
- c.1470 **Alexander MacMulen**: Inscription on cross at Kilmory, Knap [Steer & Bannerman, 151-2]
- 1473 **McMwlane the barbour**: Paid for "...the leichcraft done .. to the litil boys of the Chalmire..." [A.L.H.TREAS., I, 68]
- 1484 **Sir William McMelane & Michael McMelane Ynr**: Witness [Lag Charters, No. 34]
- 1486 **Johannem Macmwlane/Makmulane**: Obstructs Chamberlain of Galloway gathering taxes [ER, IX, 380 & 460]
- 1488 **Mychel McMyllane & Walter Makmyllane**: Had goods stolen in barony of Earlston/Glenken [RSS, I, 1, No.1]]
- 1490 **John Makmulane in Glenken**: Assessed for tax on the "motte" (i.e. castle) of Earlston
- 1490 **Cuthbert McMilane**: Witness for a Grierson of Lag charter [Lag Charters, No. 40]
- 1492 **Huchone Makgillemuil**: Arbitrator of church lands of Croy, Nairnshire [Genealogical Deduction...Rose of Kilravock]
- 1495 **Johne & Colline McMyllane**: Remissions paid to at Kirkcudbright [A.L.H.TREAS., I, 215]
- 1498 **Huchone McGillemuile**: Tenant in Bothtbeg (Inverness, Nairn or Moray) [Acts of Lords of Council, II, page 273]
